- Periodically conducting self-verifications, OMS gap assessments and statutory audits.
- Identifying and evaluating occupational health risks related to its operations and carrying out pre-employment and periodic medical check-up of its employees and contractors.
- Implementing programs and appropriate protective measures to control such risks.
- Continuous monitoring of work environment and emissions and taking measures to achieve better environmental performance.
- Interacting with local communities on operations, likely hazards and emergency response systems.
- Keeping abreast of latest international codes, standards and practices and adopting the same wherever applicable.
